

ANTONIO INCAMPO is Full Professor of Philosophy of Law at the Department of Law of the University of Bari Aldo Moro.

After graduating in Philosophy at the Catholic University of “Sacro Cuore” in Milan, where he was a student of Luigi Lombardi Vallauri, he earned the Doctorate in “Philosophy of Law, General Theory of Law and Political Philosophy” at the University “La Sapienza” of Rome

He attended specialization courses in various foreign universities, collaborating, among others, with Herbert Schambeck, one of the major heirs of “Vienna School of Law” (the “Wiener Rechtstheoretische Schule,” quoting the title of the famous work published precisely by Schambeck with Hans Klecatsky and René Marcic).

He was Researcher (confirmed), then Associate Professor (confirmed) of Philosophy of Law in the Faculty of Law at the University of Bari.

Former Director of the “Department of Criminal Law, Criminal Procedural Law and Philosophy of Law” and Former President of the degree courses of the Second Faculty of Law at the University of Bari, in 2013 he is appointed member of competence of Academic Senate of the University of Bari in the “Presidium Quality” at the same University for the Macro-area of legal and economic sciences.

Member of the National Scientific Council of the “Italian Society of Philosophy of Law,” he is called as a foreign partner in various projects of the European Union at the Faculty of Social Sciences of the University of Gdańsk and at the “Instituto de Humanidades” of University “Rey Juan Carlos” of Madrid. In 2016 he held a series of lectures at the National Academy of Sciences in Kiev.

He collaborates with many scientific reviews of international interest. He is, among other things, member of the Editorial Board of the “Rivista di filosofia del diritto/Journal of Legal Philosophy” (official review of the Italian Society of Philosophy of Law”). He currently leads the editorial series “Unità del sapere giuridico. Quaderni di scienze penalistiche e filosofico-giuridiche” (Cacucci Editore, Bari), and the review “L’Ircocervo. Prima rivista elettronica italiana di Metodologia giuridica, Teoria generale del diritto e Dottrina dello Stato/*First Italian Digital Journal of Legal Methodology, General Theory of Law and Doctrine of the State*” (Fondazione Gentile, Venice); he also directs the “Threats to Constitutional Systems”, section of the “Encyclopedia of Contemporary Constitutionalism” for the Springer Nature (Berlin, London, New York).

Appointed by the Ministry of University and Research as scientific reviewer of the “Research Programs of Relevant National Interest” (PRIN), he is part of the committee of experts for the refereeing of various scientific journals and series. On 24 March 2014 he gave the official opening lecture for the inauguration of the 2013/2014 academic year of the University of Bari Aldo Moro.

He is the author of numerous studies on philosophy and semiotics of legal language. Among his main works: *Sul fondamento della validità deontica. Awarded in 1998 of the “Grand Decoration of Honour” [*Großes Ehrenzeichen*], an honorary title of the President of the Republic of Austria for cultural merits. In November 2009 he received the “Gold Medal” of the Foundation “Giuseppe Chiarelli” for “Fancesco Santoro Passarelli Award.”
